- Freight:** All goods are inspected for quality and carefully packaged. All shipments are FOB factory unless otherwise noted. Buyer owns goods in transit. Loss or damage to product in transit is repaired or replaced at Dayus' sole discretion. The buyer must report loss or damage (visible or concealed) at once to the carrier and file a claim. If not shipped on Dayus' account for any reason, such as the buyer's request, loss or damage is the responsibility of the buyer.
- Returns:** Contact the factory for return authorization. No returns will be accepted without prior written permission. A re-stocking charge will be determined on all returns to cover cost of handling, inspection, and re-packaging. Returns are not accepted on customer damaged products, custom made orders or sizes unlikely for resale at Dayus' discretion.
- Cancellation:** The buyer is responsible for any non-recoverable cost incurred, determined by Dayus Register & Grille, before cancellation of released orders.
- Warranty:** A period, not exceeding one year from date of shipment, Dayus warrants its products to the extent that we will furnish a new product to replace that which is proved defective by Dayus. Replacement will only be made upon return of product to factory at the customer's expense. No warranty is included against property damage, personal or physical injury to any person or persons resulting from handling or as a result of improper installation.
- Credit:** Shipment will be made on an open account to firms with established credit ratings. A finance charge of 1½% per month or 18% per annum will be charged on all accounts 30 days past due. Legal fees will be charged where collection action is instituted. No shipments will be made when accounts are over 60 days.
- Credit Card:** Credit card payments do not qualify for any discounts for any prompt payment. Customers who prefer to pay by credit must note on the order when it is placed. A 2% convenience fee is issued at the time of invoice.
- Taxes:** Prices do not include Federal, State, Provincial, or local Sales Tax or other Excise Taxes which may be imposed on the sale of our product.
